MINUTES OF THE SPECIAL MEETING OF THE BOARD OF DIRECTORS OF HEATHER RIDGE METROPOLITAN DISTRICT NO. 1

Held October 15, 2020, at 4:00 p.m. held via Conference Call

Director Attendance/ A meeting of the Heather Ridge Metropolitan District No. 1 (the "District") was held as shown above and in accordance with the Qualifications applicable statutes of the State of Colorado. A public audience was The following Directors, having confirmed their in attendance. qualification to serve on the Board, were in attendance: Errol Rowland Patt Dodd Bette Secord Van Lewis Kay Griffiths Joan Beldock Also present for the District: Sean Allen, Esq., White, Bear Ankele Tanaka & Waldron, general counsel; Diane Wheeler, Simmons & Wheeler, P.C., District accountant; Larry Ransford and Barry McConnell Call to Order/Ouorum Director Rowland noted a quorum was present and each Director present confirmed they were qualified to serve. Director Rowland referenced the District's mission statement. **Conflict** Disclosure Mr. Allen advised the Board that, pursuant to Colorado law, certain disclosures might be required prior to taking official action at the meeting. Mr. Allen inquired whether members of the Board had any disclosures of potential or existing conflicts of interest with regard to any matters scheduled for discussion at the meeting. Director Rowland reminded the Board that he is performing District website maintenance and management services for which compensation is paid. All Board members confirmed there are no other conflicts of interest. Approval of Agenda The agenda was approved by the Board.

Minutes The minutes from the April 16, 2020, meeting was discussed. Following discussion, upon motion made and seconded, the Board approved the minutes.

- **Community Reports** Director Lewis provided the Board an update on the security incidents report and summary to the Board.
- Public Comment Resident, Ken Reiff discussed with the Board the errant golf balls from the 16th tee at the golf course. He told the Board that he appreciates the mitigation efforts from the golf course thus far, but it

is still an issue for him and he plans to have additional conversations with GCAT. Director Rowland discussed the covid-19 effects on the golf course and that it had increased play in 2020. Director Rowland noted that some of the natural errant ball deterrents were as old as 40 years and unhealthy vegetation and trees occasionally have to be cut down and newly planted trees and vegetation take time to mature and won't stop the golf balls right away. It was noted that the golf course initiated a program to address errant golf balls through reasonable mitigation efforts and cost ability. It was also noted that homeowners living in a golf course community can set up their own selfprotections too, report errant golf strikes to the pro shop/marshall with a description of the golfer when known. The Board reiterated that it remains open HOA proposals to address errant golf ball strikes to be done in a cooperative and costing sharing manner.

Resident, Jane Klein noted to the Board that she has lived along a fairway in Heather Ridge for over 20 years, and has had the occasional broken window but none in the last seven years so she doesn't see an issue.

Mr. Reiff also asked about the certain statements contained in the annual audit. Ms. Wheeler addressed and responded to Mr. Reiff's inquiry.

Resident, John Lane questioned the Board why the taxes have gone up 20%. Ms. Wheeler corrected Mr. Lane by responded that the District's mill levy did not increase but it was likely that his home value increased resulting in a higher total property tax bill. Ms. Wheeler also noted that the District has lowered its mill levy from 2016 to 2021.

Financial Statements/Payment of Claims	Ms. Wheeler presented the financial statements dated September 30, 2020 and payment of claims. Following discussion, upon motion duly made and seconded, the Board approved the financial statements and accepted the payment of claims.
2020 Budget Amendment Hearing	Director Rowland opened the public hearing on the 2020 Budget Amendment. Mr. Allen noted that the notice of public hearing was provided in accordance with Colorado Law. No written objections have been received prior to the meeting. There being no public comment, the hearing was closed.
Consider Adoption of 2020 Budget Amendment Resolution	Mr. Allen reviewed the Resolution Amending the 2020 Budget with the Board. Following discussion, upon a motion duly made and seconded, the Board unanimously adopted the resolution amending the Enterprise Fund to \$1,237,333 and the Catastrophic Fund to \$200,000.

2021 Budget Hearing	Director Rowland opened the public hearing on the proposed 2021 Budget. Mr. Allen noted that the notice of public hearing was provided in accordance with Colorado law. No written objections have been received prior to the meeting. After hearing public comments, the hearing was closed.
Consider Adoption of 2021 Budget Resolution	Mr. Allen reviewed the 2020 Budget Resolution with the Board. Following discussion, upon a motion duly made and seconded, the Board unanimously adopted the resolution adopting the 2020 Budget, appropriating funds therefor and certifying 14.500 mills for the general fund and 19.000 mills for the debt service fund.
Golf Course Operation Report	
General Operations	Mr. Ransford provided a summary to the board and noted the number of marshalls/hours and restricted cart hours. He also addressed the social distancing questions of the golfers, and the new trees that were installed.
Resident Discount Program	Mr. Ransford responded to Paul Kullback's inquiry and request that the golf course offer a resident discount pricing of a 10% discount on premium card purchases. Mr. Ransford summarized the financial impacts to the golf course that could result if a discount program was

offered. The Board asked Mr. Ransford to provide it with more details about the pros and cons of discount pricing.

GCAT OperationsThe Board discussed renewal of the GCAT Operations ManagementManagementAgreement. Following the discussion, upon a motion duly made and
seconded, the Board approved the renewal with no new terms.

HEATHER RIDGE METROPOLITAN DISTRICT NO. 1 ANNUAL ADMINISTRATIVE RESOLUTION (2021)

At the special meeting of the Board of Directors ("**Board**") of the Heather Ridge Metropolitan District No. 1 ("**District**"), City of Aurora, Arapahoe County, Colorado, held at 4:00 P.M., on Thursday, April 15, 2021, it was moved to adopt the following Resolution:

WHEREAS, the District was organized as a special district pursuant to an Order and Decree of the District Court in and for the County of Arapahoe, Colorado (the "**County**") and is located entirely within the City of Aurora, Colorado; and

WHEREAS, the Board has a duty to perform certain obligations in order to assure the efficient operation of the District and hereby directs its consultants to take the following actions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

1. The Board directs legal counsel to cause an accurate map of the District's boundaries to be prepared in accordance with the standards specified by the Division of Local Government ("**Division**") and to be filed in accordance with § 32-1-306, C.R.S.

2. The Board directs legal counsel to notify the Board of County Commissioners, the County Assessor, the County Treasurer, the County Clerk and Recorder, the governing body of any municipality in which the District is located, and the Division of the name of the chairman of the Board, the contact person, telephone number and business address of the District, as required by 32-1-104(2), C.R.S.

3. The Board directs legal counsel to prepare and file with the Division, within thirty (30) days of a written request from the Division, an informational listing of all contracts in effect with other political subdivisions, in accordance with § 29-1-205, C.R.S.

4. The Board directs legal counsel to cause the preparation of and to file with the Department of Local Affairs the annual public securities report for nonrated public securities issued by the District within sixty (60) days of the close of the fiscal year, as required by 11-58-101, *et seq.*, C.R.S.

5. The Board directs the District's accountant to: 1) obtain proposals for auditors to be presented to the Board; 2) to cause an audit of the annual financial statements of the District to be prepared and submitted to the Board on or before June 30; and 3) to cause the audit to be filed with the State Auditor by July 31, or by the filing deadline permitted under any extension thereof, all in accordance with §§ 29-1-603(1) and 29-1-606, C.R.S. Alternatively, if warranted by § 29-1-604, C.R.S., the Board directs the District's accountant to apply for and obtain an audit exemption from the State Auditor on or before March 31 in accordance with § 29-1-604, C.R.S.

6. The Board directs legal counsel, if the District has authorized but unissued general obligation debt as of the end of the fiscal year, to cause to be submitted to the Board of County Commissioners or the governing body of the municipality that adopted a resolution of approval of the District, the District's audit report or a copy of its application for exemption from audit in accordance with § 29-1-606(7) C.R.S.

7. The Board directs the District's accountant to submit a proposed budget to the Board by October 15, to prepare the final budget and budget message, including any amendments thereto, if necessary, and directs legal counsel to schedule a public hearing on the proposed budget and/or amendments, and to post or publish notices thereof, to prepare all budget resolutions and to file the budget, budget resolution and budget message with the Division on or before January 30, all in accordance with §§ 29-1-101, *et seq.*, C.R.S.

8. The Board directs the District's accountant to monitor expenditures and contracted expenditures and, if necessary, to notify the District Manager, legal counsel and the Board when expenditures or contracted expenditures are expected to exceed appropriated amounts, and directs legal counsel to prepare all budget amendment resolutions and directs legal counsel to schedule a public hearing on a proposed budget amendment and to post or publish notices thereof and to file the amended budget with the Division on or before the date of making such expenditure or contracting for such expenditure, all in accordance with §§ 29-1-101, et seq., C.R.S.

9. The Board directs legal counsel to cause the preparation of the Unclaimed Property Act report and submission of the same to the State Treasurer by November 1 if there is property presumed abandoned and subject to custody as unclaimed property, in accordance with § 38-13-110, C.R.S.

10. The Board directs the District's accountant to prepare the mill levy certification form and directs the District's legal counsel to file the mill levy certification forms with the Board of County Commissioners on or before December 15, in accordance with § 39-5-128, C.R.S.

11. The Board designates the *Aurora Sentinel* as a newspaper of general circulation within the boundaries of the District and directs that all legal notices shall be published in accordance with § 32-1-103(15), C.R.S., in the *Aurora Sentinel*, unless otherwise designated by the Board or legal counsel.

12. The Board determines that each director shall not receive compensation for their services as directors subject to the limitations set forth in \$ 32-1-902(3)(a)(I) & (II), C.R.S.

13. The District hereby acknowledges, in accordance with § 32-1-902, C.R.S., the following officers for the District:

Assistant Secretary: Assistant Secretary:	Kay Griffiths Joan Beldock
Assistant Secretary:	
Recording Secretary:	Legal Counsel

14. The Board hereby determines that each member of the Board shall, for any potential or actual conflicts of interest, complete conflicts of interest disclosures and directs legal counsel to file the conflicts of interest disclosures with the Board and with the Colorado Secretary of State at least seventy-two (72) hours prior to every regular and special meeting of the Board, in accordance with §§ 32-1-902(3)(b) and 18-8-308, C.R.S. Written disclosures provided by Board members required to be filed with the governing body in accordance with § 18-8-308, C.R.S. shall be deemed filed with the Board member shall submit information to legal counsel regarding any actual or potential conflicts of interest and, throughout the year, each Board member shall provide legal counsel with any revisions, additions, corrections or deletions to said conflicts of interest disclosures.

15. The Board confirms its obligations under § 24-10-110(1), C.R.S., with regards to the defense and indemnification of its public employees, which, by definition, includes elected and appointed officers.

16. The Board hereby appoints the District's legal counsel as the official custodian for the maintenance, care and keeping of all public records of the District, in accordance with §§ 24-72-202, *et seq.*, C.R.S.

17. Pursuant to § 24-6-402(2)(c), C.R.S., the Board hereby designates the northwest corner of Danbury Park as the District's 24-hour posting place for notices of meetings.

18. The Board determines to hold regular meetings on the third Thursday of April and October, at 4:00 P.M. at 13521 E. Iliff Avenue, Aurora, Colorado. Other meetings may be held during the year as deemed necessary. Notice of the time and place for all regular meetings shall be posted in accordance with § 32-1-903, C.R.S.

19. In the event of an emergency, the Board may conduct a meeting outside of the limitations prescribed in § 24-6-402(2)(c), C.R.S., provided that any actions taken at such emergency meeting are ratified at the next regular meeting of the Board or at a special meeting conducted after proper notice has been given to the public.

20. For the convenience of the electors of the District, and pursuant to its authority set forth in § 1-13.5-1101, C.R.S., the Board hereby deems that all regular and special elections of the District shall be conducted as independent mail ballot elections in accordance with §§ 1-13.5-1101, *et seq.*, C.R.S., unless otherwise deemed necessary and expressed in a separate election resolution adopted by the Board.

21. Pursuant to the authority set forth in § 1-1-111, C.R.S., the Board hereby appoints Ashley B. Frisbie, of the law firm of WHITE BEAR ANKELE TANAKA & WALDRON, Attorneys at Law, as the Designated Election Official (the "**DEO**") of the District for any elections called by

the Board, or called on behalf of the Board by the DEO, and hereby authorizes and directs the DEO to take all actions necessary for the proper conduct of the election, including, if applicable, cancellation of the election in accordance with § 1-13.5-513, C.R.S.

22. In accordance with § 1-11-103(3), C.R.S., the Board hereby directs the DEO to certify to the Division the results of any elections held by the District and, pursuant to § 32-1-1101.5(1), C.R.S., to certify results of any ballot issue election to incur general obligation indebtedness to the Board of County Commissioners or the governing body of the municipality that adopted a resolution of approval of the district and file a copy of such certification with the Division of Securities.

23. The Board directs legal counsel to cause a notice of authorization of or notice to incur general obligation debt to be recorded with the County Clerk and Recorder within thirty (30) days of authorizing or incurring any indebtedness, in accordance with § 32-1-1604, C.R.S.

24. Pursuant to the authority set forth in § 24-12-103, C.R.S., the Board hereby designates, in addition to any officer of the District, George M. Rowley of the law firm of WHITE BEAR ANKELE TANAKA & WALDRON, Attorneys at Law as a person with the power to administer all oaths or affirmations of office and other oaths or affirmations required to be taken by any person upon any lawful occasion.

25. The Board directs legal counsel to cause the preparation of and filing with the Board of County Commissioners or the governing body of the municipality that adopted a resolution of approval of the District, if requested, the application for quinquennial finding of reasonable diligence in accordance with §§ 32-1-1101.5(1.5) and (2), C.R.S.

26. The Board directs legal counsel to cause the preparation of and the filing with the Board of County Commissioners or the governing body of any municipality in which the District is located, the Division, the State Auditor, the County Clerk and Recorder and any interested parties entitled to notice pursuant to 32-1-204(1), C.R.S., an annual report, if requested, in accordance with § 32-1-207(3)(c), C.R.S.

27. The Board directs legal counsel to obtain proposals and/or renewals for insurance, as applicable, to insure the District against all or any part of the District's liability, in accordance with \$ 24-10-115, *et seq.*, C.R.S. The Board directs the District's accountant to pay the annual SDA membership dues, agency fees and insurance premiums, as applicable, in a timely manner. The Board appoints legal counsel to designate the proxy for the SDA Annual meeting for voting and quorum purposes.

28. The Board hereby opts to include elected or appointed officials as employees within the meaning of § 8-40-202(1)(a)(I)(A), C.R.S., and hereby directs legal counsel to obtain workers' compensation coverage for the District.

29. The Board hereby directs legal counsel to prepare the disclosure notice required by § 32-1-809, C.R.S., and to disseminate the information to the electors of the District accordingly.

30. The Board hereby directs its legal counsel, accountant, manager and all other consultants to adhere to the Colorado Special District Records Retention Schedule as adopted by the District.

31. The Board hereby directs legal counsel to prepare and record with the County Clerk and Recorder updates to the disclosure statement notice and map required by § 32-1-104.8, C.R.S., if additional property is included within the District's boundaries.

32. In accordance with § 38-35-109.5(2), C.R.S, the District hereby designates the President of the Board as the official who shall record any instrument conveying title of real property to the District within 30 days of any such conveyance.

33. The Board directs the District's accountant to prepare and submit the documentation required by any continuing disclosure obligation signed in conjunction with the issuance of debt by the District.
