

# Heather Ridge Metropolitan District: Report to the community

The golf season is winding down. However, given the weather and the Broncos' season, golfers will continue to play and pay for the game they love. Although the Heather Ridge Metropolitan District's (HRMD) golf season hasn't ended yet, present indications point to a loss for the 2011 Enterprise Budget by Dec. 31.

Profits and losses are normal aspects of running a business. Throughout 2011, the HRMD and its managers (the Golf Club at Heather Ridge, GCat) have been carefully analyzing income and expenses, making changes as needed. Those changes, and others to come, have laid the foundation for the 2012 Annual Budget and golfing season. This article outlines budget history, operations and issues, and plans for next year.

**Budgets.** The 2011 Budget for golf and clubhouse operation (called the Enterprise Fund) was based on 2010's successful year and marketing projections. HRMD's first full year of golf operations, 2010, ended on a positive note with only a small loss due to budget timing. With a cautious but positive attitude, the 2011 Enterprise Fund projected \$1.2 million in income and \$1 million in expenses. Like most budgets, it's a financial guide given to future events.

The HRMD uses four funds within its Annual Budget (general, enterprise, capital projects and debt service).

This article will focus on the General and Enterprise Funds. The General Fund supports HRMD governmental operations, administration and asset management. The Enterprise Fund runs golf operations as managed by GCat, which oversees daily golf operations and reports to HRMD.

All HRMD financial reports are online at www. HRMDco.org. Click on the HRMD button on the left side of the screen for reports. At the next screen, click on the red and underlined Link to HRMD01 Meeting Minutes/ Financials. Organized chronologically, by month, are Simons-Wheeler's accounting reports and the HRMD's Yellow Line — a profit-and-loss summary outlining key operational issues and fund balances.

As of September 2011, the Yellow Line's year-to-date showed the golf course operating at a loss. However, in December of each year, the golf course sells "golfing packages" for the next year, thus generating significant income. December's sales will be included in the 2011 budget year.

Golf and Clubhouse Operations in 2011. The HRMD's primary mission is twofold: to preserve the open space best utilized as a golf course, and to protect and maintain HRMD assets. To meet those goals, the See facing page

balance of this article will outline events and issues for 2011, and make clear and reasoned options for the 2012 Annual Budget.

Three events in 2011 combined to disrupt the Enterprise Fund (including its reserves). The first one was over staffing to meet anticipated operational and marketing needs. The golf course was prepared for greater activity, which did happen. Although more rounds of golf have been played in 2011 versus 2010, expenses offset this positive outcome.

Secondly, the springtime irrigation project proved to be longer and more disappointing to the revenue and the "golfing experience" than anticipated. To attract and bring back golfers, especially ones lured by other golf courses, marketing costs and golfing concessions grew (e.g., discounted green fees, golf with lunch or cart, etc.).

Lastly, but perhaps most importantly, the costs of maintaining, operating and managing the HRMD's clubhouse building and site grew dramatically. With a new restaurant lease came much needed, but costly, improvements, repairs, and unexpected expenses (a sewer line collapsed, unsafe windows were replaced, etc.). These non-golf related expenses (and this is important to note) depleted reserve funds that otherwise would have been available for golf operations.

**Operating Issues.** As a quasi-municipal corporation and political subdivision of the State of Colorado, the HRMD must operate within certain rules — made when bonds were issued and required by state statutory law.

The HRMD has approached budget and operational issues with one simple philosophy: golf operations cannot use tax money. That statement defines the use or non-use of tax dollars in creating budgets for managing assets versus a golf operation.

The HRMD's assets include the clubhouse building and its grounds along with the 85 acres of open space with wells, walls, irrigation systems, and walking paths. These and other physical assets are distinctly separate from golf course operations, and should be budgeted and funded accordingly. In 2010 and 2011, the budgeting for golf operations and HRMD assets overlapped, resulting in some confusion about funding sources. The 2012 Budget will remove the overlap.

Solutions for 2011 and 2012. The HRMD and GCat have analyzed what jobs and duties are necessary to run the golf operation within a balanced budget. The recent resignation by Mike Ritter as the golf pro and clubhouse manager is a case in point. Although he will be greatly missed, his position will not be replaced pending further study. For now, GCat board member Larry Ransford will oversee golf operations.

Larry has been intimately involved in HRMD assets and golf operations. Living on the 2nd fairway in Cobblestone Crossing, Larry has an extensive background in management and operations as a retired Marriott Corporation executive. One of his many corporate duties included making hotels and resorts profitable — a perfect match for present needs. His immediate goal for 2011 is to reduce expenses while keeping professional services and standards up to par! He will also prepare operating and budget recommendations for 2012.

The HRMD is also working with its bond-holding

bank, US Bank, to reallocate reserve funds, change certain bond restrictions, and improve operating guidelines. One goal is better cost and operational controls by separating HRMD physical assets from golf operations. This would include reserve and repair/maintenance issues for the clubhouse and other non-golf assets.

Another need is to "grow the golf income" through marketing, especially Internet and smartphones. Due to the poor economy, the golf industry is more competitive than ever. The HR Golf Course fits a great marketing niche with a challenging course at reasonable rates. In a convenient location, it can be played under four hours — especially nice for business people and active retirees.

Lastly, the support and loyalty of our men and women's golf league members cannot be underestimated. Many were members when Heather Ridge was a private club, and stayed when it went public. Their continued play and purchase of golf packages is important to golf operations, a fact not lost on HRMD and GCat. Heather Ridge's "golfing packages" provide many services not included at other courses — discounted golf, unrestricted usage, premium tee times, range balls and carts, and seasonal benefits.

The clubhouse and its five-acre site have great development potential, so HRMD is looking into that. The coming light rail station at Iliff and I-225 has already rejuvenated local real estate, so why not Heather Ridge? Selling only the clubhouse site would eliminate maintenance costs and increase HRMD liquidity. In this discussion and possible endeavor, the HRMD has asked the United Associations of Heather Ridge (UAHR) to be an active voice for taxpayers and voters.

The golf course operation is viable and can be profitable. In the past 18 months of HRMD ownership, operational data clearly shows its potential — and some weaknesses. Hurting golf profits in 2011 were labor/salary expenses and maintenance/reserve costs, which has included and overlapped non-golf related management and operation of HRMD assets. Budgeting and planning options for 2012 include: selling the clubhouse asset and leasing back space for golf operations, removing the golf/non-golf overlap noted above and re-allocating tax revenue in the annual budget without increasing taxes, or increasing General Fund property taxes if the public wants the HRMD to keep ownership of and improve the clubhouse and its five-acre grounds.

United Associations of Heather Ridge (UAHR). It is more important than ever that HOA boards in Heather Ridge stay active in the UAHR. A taxpayer advocacy group, UAHR watches, listens, and advises the HRMD about public opinion.

Led by Josie Spencer, this board has nine representatives from the 10 HOAs in HRMD.(Country Club Ridge's board of directors has declined to appoint a representative from its board.) Developing the clubhouse site could have many implications, not the least of which is high-rise construction. Zoned for 18-story development, the 5-acre site is prime real estate due to nearby amenities. Public opinion will be important concerning this issue. # **Heather Ridge Market Report**

As 2011 winds down, what's in store for Heather Ridge property owners? Anyone thinking of buying or selling should revisit his or her reasons by seeking mature, professional real estate advice. Today's market is not for the faint of heart.

Since 2008, national real estate values have plummeted, including Heather Ridge and the Denver metro area. Along with job loses and economic uncertainty, some owners walked from their properties, thus feeding the foreclosure maelstrom. For those who stayed and paid their bills, what does the real estate market hold for them?

Lower-priced homes, defined as under \$200,000, are selling quickly with slightly rising prices. Remodeled or homes in good condition are selling nicely if their prices are reasonable and fit market expectations. However, over-priced homes struggle for buyers with much to choose.

Careful pricing, value issues, and marketing conditions need careful analysis and agreement. 

Congratulations are in order! I am proud to report that two of the UAHR communities have come on board and are ready to "GO with Neighborhood Watch." Those two are Burgundy and Cobblestone. This is due to the hard work of the Area Coordinators and their Block Captains.

#### CARE TO JOIN THE RACE?

Who will be next? It appears that crime continues to occur in some of those communities that have not established their program. This may continue to happen until all are involved and the entire UAHR is "Crime Free."

Please believe! It doesn't take much of your time to volunteer. Isn't it worth it to make you feel safe? To take your life back?

#### You Are In Coyote Country

NEVER feed coyotes, either purposefully or indirectly:

- NEVER feed a coyote a fed coyote is an aggressive or dead coyote. If you see or suspect someone is feeding coyotes, immediately contact Parks and Open Space Naturalist staff, 303-326-8948.
- Do not leave pet food outside, day or night. Period. • Do not leave trash uncovered or out on the curb overnight.

If you live near or adjacent to a park, trail, golf course, or natural open space area:

- It's a good idea to keep small pets in sight or accompany them outside even if you have a fenced yard, particularly after dusk when coyotes are more active.
- Remember, if you live in Aurora or any Front Range community you probably have these wild neighbors. They are highly adapted to our urban landscape, which means they may travel through your subdivision in search of food.

#### If you are followed by a covote:

Coyotes may follow humans if they have been fed by humans or if there is a den in the area. Coyotes associate with and protect dens in the spring and early summer when pups are likely to be present. Discourage coyotes from following you and your pet.

- Be as BIG and LOUD as possible.
- In a loud and forceful voice, command the coyote to go away.
- Use arm gestures to exaggerate your size.
- Keep small children near you; do not let them run away.
- ALWAYS keep your pets on leash. Collect small pets into your arms. Keep larger pets close to you.
  - Throw objects (not food) adjacent to the covote.
    - Slowly move toward a busy, populated area.

There is no need to run. Consider adjusting your walking route for a few weeks if you think there is a den in the area.




## **DID YOU KNOW?**

Jimmy Connors played in a charity tournament at the Heather Ridge Tennis Club in the 1970s? Connors held the top ranking for 160 consecutive weeks from July 29, 1974 to Aug. 22, 1977 (record at that time) and an additional eight times during his career

(a total of 268 weeks). He won eight Grand Slam titles and two Grand Slam doubles titles with Ilie Năstase. He was also a runner-up seven times in Grand Slam singles, a doubles runner-up with Nastase at the 1973 French Open, and a mixed doubles runner-up with Chris Evert at the 1974 US Open. Connors is also the only man to win U.S. Open singles championships on grass, clay, and hard courts, which is a feat that will never be duplicated.

Connors is the first male player to rank No. 1 for more than 200 weeks in total and the first male player to be No. 1 for more than 5 years (268 weeks) in total. He is the only male player to win more than 100 singles titles during his career. He is also the only male player to reach 31 Grand Slam semifinals and 41 Grand Slam quarterfinals in his career.




Parking outside of garages. Please read the







parking contributes to clutter and congestion. It could restrict emergency vehicles, and limits snow removal. Lastly, car thieves and vandals love outside parking.

Community Rules and Regulations. The published community directory includes HRS's Rules and Regulations. These are for the entire community, not certain streets, households, or sections. Its policies and enforcement cannot be selective or arbitrary. Failure to follow these is unthinkable.

The board recently heard testimony by concerned owners and residents about children playing on private interior streets. This happens more in the warm-weather months, but also reflects the limited "play areas" for children. The board will be revising its Rules and Regulations soon, and will address this issue and others. To register ideas or comments, please email Sue Daigle as noted above.

The board recently mailed notice to all offsite owners concerning rental property in Heather Ridge South. The letter requires owners to inform tenants about the Rules and Regulations, matters of recourse and communications, and expectations for all residents. Heather Ridge South has always prided itself by welcoming everyone to the community — but in doing so, everyone needs to be informed and cooperative.

Annual Meeting and Holiday Dinner. The Annual Meeting will be Dec. 6, and the Holiday Party/Dinner on Dec. 10. Mark your calendars today to not miss these two important events.

Start thinking snow season. One morning soon, you will look out your windows and see snow. Be prepared as follows. Park inside your garage. Make sure your hoses are disconnected. Be "shovel ready" to clear your walks and patios. If you are physical unable to clear your walks, please contact Sue Daigle for assistance.

When it snows, please don't use chemicals on ice or snow. This is especially important given the new concrete driveways. In the past, the HOA has placed buckets at key locations with special ice melt chemicals. Now, all chemicals are being researched, so don't use any until further notice.

**Winterizing Your Home.** The weather is starting to change, and cold weather will be here before long. Here are some tips for winterizing your home:

- Disconnect your hose before the first hard frost. If your outside spigot freezes back into your unit it could burst and flood your basement.
- Replace the filters in your furnace for more efficient air flow.
- Check weather stripping around doors and windows. Outdoor Water Audit. On July 18, the Center for Resource Conservation (CRC) performed an outdoor water audit for Chimney Hill. This was a free service that helps monitor water usage. The CRC visually inspected all 80 watering zones, performed catch cup and pressure tests as well as soil and root depth tests. They found that while our sprinkler system is older, it has generally been well-maintained.

CRC also complimented the community on use of the Weather Trak system and the new xeriscape, both of which are great ways to save water. CRC also pointed out areas for improvements, including changing to more efficient sprinkler heads, making some repairs, and moving or capping some sprinkler heads.

Using the findings of the water audit, CH will work with the landscape contractor to continue to find ways to water more efficiently. The board would like to thank Pam Akiri for organizing the audit with CRC and to thank both CRC, and Marc LaDue, from A Perfect Landscaping, for

their work on the audit.

Indoor Water Audits. In addition to evaluating outdoor water usage, each



resident can do their part by evaluating the water you use inside your homes. The City of Aurora Water Conservation District will provide a free indoor water audit on your home. The audit will include:

- testing how many gallons per minute your shower and faucets use.
  - testing for leaks in showers, faucets, and other areas.
- providing aerators and other tools to reduce water usage.
- providing information on water efficient appliances, including rebates available.

Several residents have already had water audits and found them to be very helpful. Audits are available Monday through Saturday. To schedule, please call 303-739-7351.

In reference to Mr. Sherman's claim that the Chimney Hill reserve funds are being depleted, these funds have been expended in accordance with a long-term business plan. The funds spent this past year are in sync with recommendations contained in the Reserve Study done in 2010.

The Chimney Hill annual meeting will take place on Nov. 15, at 6 pm, in the ballroom of the Heather Ridge Golf Course Clubhouse. All Chimney Hill homeowners will receive written notification of the meeting and are encouraged to attend.
