

The special speaker for the evening was an officer from EMATT (Auto Theft Task Force). He presented a vast amount of valuable information regarding what residents can do to cut down and/or eliminate auto theft. Report *all suspicious activity* to the Aurora Police Department, 303-627-3100, or in extreme circumstances, call 911.

If you need information regarding what constitutes *suspicious activities,* you may obtain a brochure from your Block Captain.

By your watchful eye, and follow up, we can eliminate all crime in our communities. It is each and every resident's responsibility, whether they are an owner or a renter, to be an observant occupant of their community.

Drop It, Lock It, Stop It. The Arapahoe County Sheriff's Office Program entitled, "Drop It, Lock It, Stop It" has its deputies always on the look out for open, unattended garages. If a deputy spots an open garage door, the Sheriff's office mails out a letter to the homeowner about the safety concern. When the program began in 2004, 30 percent of all residential burglaries in Centennial and Arapahoe occurred through open garage doors. For the first six months of 2011, that figure came down to 11 percent.

During the summer months, they typically see a rise in this type of burglary. It takes less than a minute for someone to remove items of value from an open garage and get away.

An open garage is an invitation to criminals. To help reduce your potential for being victimized, follow these easy steps.

Drop It. Dropping your garage door is the first line of defense against unwanted entry into your home.

Lock It. Locking the door that leads from your garage into your home reduces unwanted entry. Doors should be equipped with one-inch deadbolt locks. The strike plates need to be reinforced with screws that go into the door frame.

Stop It. Don't make crime easy. It only takes a minute to secure your home.

Heather Ridge Metropolitan District: Report to the community

The mission of the Heather Ridge Metropolitan District (HRMD) is to preserve the Heather Ridge open space — maintained best as a golf course. December began the third year of HRMD ownership of the Heather Ridge open space and operations of the golf course and clubhouse. Together, Heather Ridge (HR) homeowners have accomplished much in an uncertain economy and the challenging golf industry.

Major capital investments were made during the first two years of ownership. These expenditures were long overdue as the property had been neglected by previous owners over the last 35 years. A new water well was installed in 2010, south of Iliff. A new irrigation system, state of the art, was completed in 2011, north of lliff. Dependable water delivery systems are essential for continued success of the course.

Although many of these investments are not visually apparent, they are vital to the future and integrity of Heather Ridge's open space.

Golf revenue for the last two years has been triple the revenues collected in 2008 and 2009. Golf expenses also were higher. Beginning two months ago, fixed expenses have been cut significantly. Controls and balances are in place to assure expenses remain in check. A special thanks to the HR women and men golfers who

have made commitments to the 2012 golf season at Heather Ridge. They demonstrated their financial support by purchasing annual golf memberships and other prepaid fees. Details of all financial reports continue to be posted on the website, HRMDco.org.

In the summer of 2009, HR clubhouse alternatives were presented at each of the eight pre-open space purchase community meetings. The HRMD and the United Association of Heather Ridge (UAHR) will continue to analyze options for the clubhouse. When a course of action is determined, information meetings will be held so that feedback can be obtained and consensus reached.

In conclusion, everyone can be proud of the golf course asset and the accomplishments of HRMD thus far, but there is still a great deal of work to be done. You can help by:

• Praying for great golfing weather. (There were zero golfing days in December.)

• Continuing to promote this great golfing venue via social networking!

• Continuing to golf with friends and enjoying the beautiful open space,

• Supporting the community gathering place and restaurant (Noonan's Tavern).

"What type of glass do homes on golf courses install to prevent stray golf balls from breaking the glass?"

The following information is the result of research done by HRCA on this frequently asked question:

Regular Glass. Most of the time, people just use regular glass and have special insurance for an "accident" that occurs from a stray golf ball.

The added expense of Lexan or hurricane windows isn't usually worth it financially unless you're right in the line of fire and you have a broken window every month.

Film. There are some "plastic" films that can be applied to regular window glass that makes it virtually shatterproof.

The glass will break, but is held in place by the film. It impedes quick entry through windowpanes and glass doors, helps hold panes in place to minimize flying glass due to violent weather or accidents, and is available in clear safety film or with a tinted sun control option.

The films also help insulate your home by trapping warm air in and keeping cold out.

Fiberglass Screen. If you have trouble with occasional breakage, you could try having a fiberglass screen made for the window.

Fiberglass is less expensive, and has the advantage of not "denting" when hit or pushed. However, the fiberglass mesh is somewhat more opaque than aluminum mesh, which darkens the external appearance of the window and reduces the amount of light transmitted from outside. In addition, a fiberglass screen degrades rapidly with exposure to UV light, leading to fraying and breaking after just a few years, unlike aluminum that lasts considerably longer.

Lexon or Hurricane Windows. Bullet proof glass is known by the trademark "Lexan" and is also known by the generic name Polycarbonate. Instead of shattering upon impact, the glass is held intact within its frame.


It may or may not crack or break, depending upon the nature and force of the blow(s).

Lexan windows are about 3–4 times the cost of regular glass windows, so you have to weigh the pros and cons to see if it makes sense for you.

The strength is determined by the amount of force used to break or shatter the glass.

Just be sure you check the "unbreakable" strength ratings of the glass and consider all the other options

Heather Ridge Real Estate Update

Overall, Denver's 2011 real estate market ended upbeat and poised for a better 2012 season. Pending statistics for 2011 will show two metro area home markets one below and one above \$400,000 foretelling the story for 2012 — a tale of two markets!

Home prices below \$400,000, and in particular below \$200,000, are now stable. Helping this have been two factors — declining inventory and increasing demand. If the laws of supply and demand have any importance, prices should rise if allowed to.

Homes above \$400,000 have suffered under a growing inventory marked by fewer high-income buyers. Over-

built in the late 2000s, the \$400,000 and above market missed the first and second foreclosure rounds of 2007 and 2009, but was squarely hit in 2010 to date. With falling prices, it is restricting lower priced homes from rising in value.

For the past six months or more, the aggregate of all "for

sale" inventory has been decreasing, but that might change soon. Lenders appear ready to accelerate pending and foreclosed homes going to market. Called the "phantom inventory" by realtors, this supply of homes was been kept from market by federal and state policies now expiring.

Strongly influencing all home sales now are tougher lending and appraisal rules. In the late 1990s, federal pressures fostered "easy loan qualification programs" that significantly contributed to the national housing bubble. It will take time to determine what new policies and procedures work, and those that don't.

Heather Ridge property values are improving. In 2011, Pete and Van sold over a dozen homes here, helping buyers and sellers understand market conditions and values. High Line Canal at Iliff Avenue Underpass


Project Description: Currently, when trail users on the High Line Canal Trail reach Iliff Avenue, they must cross at-grade, meaning they must compete with the traffic to cross the roadway. This has created safety concerns for both trail users and vehicular traffic.

To address the issue, Arapahoe County has partnered with the Colorado Department of Transportation, Denver Water and the City and County of Denver to install a trail underpass that will allow users of the High Line Canal Trail to cross safely under Iliff Avenue. As part of the project, sidewalks will be extended over the High Line Canal on the south side of Iliff.

Project Benefits: Once complete, the new trail underpass will allow pedestrians and cyclists to travel under lliff Avenue, instead of fighting traffic in an attempt to cross the major roadway. Traffic flow will be smoother, as motorists will no longer need to stop to accommodate pedestrians and bicyclists crossing lliff Avenue.





Annual Meeting. Board Members present included Melissa Miller, Oak McEachren, Richard Bates, and Scott Shaeffer. Tom Westing from ACCU was also in attendance.

Overview of the Year. Melissa Miller presented a broad overview of the year, explaining the many capital expenditures that were accomplished, including:

1. Installed xeriscape in front of property, paid for with a grant from the City of Aurora.

2. Received a free outdoor water audit, which helped assess outdoor water usage and health of the sprinkler system.

Winterizing Your Pet

The Aurora Animal Care Division and Shelter advises these tips for you pets in winter.

• Eating snow or ice will not provide sufficient moisture to prevent dehydration in your pet.

• Continue to groom your pet in the winter. A matted coat will not provide the proper insulation against the cold.

• Indoor pets may not have grown a thick coat for winter and may require a pet sweater before going outside.

• Pets can get frostbite as easily as a human. Frostbitten areas may appear red, gray or white. Thaw those areas out slowly with a warm, damp cloth and do not rub the frozen areas.

• Salt or chemicals used to melt snow may make your pet ill. It can be fatal if ingested when your pet licks its paws.

• The sweet taste and smell of antifreeze makes it a deadly poisonous treat to animal.

• Cats often escape the cold by crawling into vehicle engines, where they can be killed or seriously injured

when the car is started. Before entering your vehicle, bang on the hood to startle any animal sleeping there.

• Only pure sand is to be used, absolutely no chemical ice melt products on new and old concrete and asphalt. Need sand? Please contact Westwind Management. Arrangements will be made to deliver a bucket of sand to your home.

• Owners are responsible for shoveling their own walkways. If physically unable to shovel snow, please contact Sue Daigle at Westwind for special assistance.

• Call Westwind about hazardous ice or snow problems. As ice melts and freezes, it becomes especially hazardous to walkers

• The HOA shovels and maintains all interior roadways and perimeter sidewalks.

• Residents who shovel outside of their property do so at their own risk.

John Chipman, who lives at Fairway 16 and owns Carefree Exteriors Inc., suggests using tempered or safety glass that is oneeighth double strength glass as opposed to the standard one-sixteenth single strength glass.

Safety glass resists shattering and is a composite of two sheets of glass with an intermediate layer of transparent plastic. Also called shatterproof glass, tempered glass has been processed by controlled thermal or chemical treatments to increase its strength compared with normal glass. Tempered glass is made by processes that create balanced internal stresses that give the glass strength. It will usually shatter into small fragments instead of sharp shards when broken, making it less likely to cause severe injury and deep lacerations.

As a result of its safety and strength, tempered glass is used in a variety of demanding applications, including passenger vehicle windows, glass doors and tables, refrigerator trays, as a component of bulletproof glass, for diving masks, and various types of plates and cookware. America's Wartime Veterans

Some 41 million Americans have served in the U.S. military since 1775; 23 million of them are still alive, 17 million of whom served during a conflict. Among them:

1. **Vietnam War (1964–75)** Many of the 8.8 million who served in uniform were draftees; 7.6 million are alive today. Thirty-five percent of all living veterans served during this time. 49,500 continued to serve through both Gulf wars. (see #3 and #5 below)

2. **Korean War (1950–53)** Often called "the forgotten war," it finally had a memorial dedicated to it in Washington in 1995. Of the 5.7 million Americans who served, 2.7 million survive. 211,000 remained in the military for the Vietnam War.

3. **Operation Desert Shield/Desert Storm** (1990–91) America's first encounter with Iraq's Saddam

Hussein involved 2.3 million military personnel, of whom 2.2 million are still present. 837,000 served during both Gulf Wars.

4. **World War 2** (1941–1945) America's most massive mobilization involved 16 million men and women, of whom 2.1 million are still alive. Of these, 147,000 served in the Korean War; 54,000 served in the Korean War and the Vietnam War.

5. **Global War on Terror (2001–)** Wars in Iraq and Afghanistan have involved 1.4 million military personnel.
